Plant Operation and Care	<p>Ensure that all plant and equipment is maintained in a tidy and presentable condition:</p> <ul style="list-style-type: none"> • Monitor the regular maintenance and care of plant & equipment, including the reporting of faults and issues through Quipcheck application to ensure the equipment is always ready for work assignments • Arrange with the Supervisor for the regular servicing of all plant and equipment and ensure COF, registrations, distance licenses etc are kept current. • Ensure machinery and equipment is regularly maintained in a good condition and abide by all manufacturers recommendations and specifications, including greasing at appropriate intervals • Ensure all vehicles are safely parked and secure when not in use • Be proactive in gaining the knowledge and skills to safely and effectively operate and maintain plant in optimum condition • Abide by all safe work practices, manufacturers recommendations and specifications
